- Mobile Internet service is provided only in Lithuania.
- The most Internet speed up to 1 Gb/s (RUN and FLY) is provided with technical capabilities. You can find out the exact information about the technical capabilities in the customer service departments or by phone (+370 5) 266 4555.
- The special offer is valid from the date of service commencement until the end of the minimum service period.
- If services provision was temporarily suspended, the smallest period is extended for this period.
- In case of early agreement termination, the Subscriber is obliged to pay compensation, taking into account the difference of the special offer and the standard tariff for the subscription fee and installation.
- Ordering the digital interactive television, the special offer is valid only when the service is ordered together with the Internet.
- Terms of contracts for IPTV and Internet service must coincide. Termination of the contract for the Internet also requires the termination of the IPTV contract.
- Making a contract for the IPTV services, a special offer is applied from the moment of the beginning of the services provision for the entire duration of the contract.
- A client wishing to change the tariff to a cheaper one before the expiration of the previous contract is obliged to pay a tariff change or compensation equal to the difference between the special offer and the standard tariff.
- A client wishing to terminate the contract before its expiration is obliged to pay compensation equal to the difference between the special offer and the standard tariff.
- If the services provision has been suspended, the client has no right to request the extension of the special offer terms.
